A. Two-Year Limited Product Warranty

If the product should prove defective in material or workmanship within that period, The Lightstrip will repair or replace the product, at its sole discretion. The Lightstrip shall not be liable for damage to any property other than the product itself. This warranty does not extend to the qualifications of the person installing the product, nor the installation or any consequences of improper installation. This warranty does not cover damage due to normal weathering, accident, misuse, acts of God or other causes beyond the control of The Lightstrip. This Limited Warranty shall extend to the products and components thereof, manufactured and supplied by The Lightstrip, but shall not extend to products, parts or equipment supplied by other manufacturers and used by The Lightstrip to manufacture the product.

THE LIGHTSTRIP DOES NOT WARRANT THE QUALIFICATIONS OF THE PERSON INSTALLING THIS PRODUCT AND THIS WARRANTY DOES NOT COVER INSTALLATION OR ANY CONSEQUENCES OF IMPROPER INSTALLATION.
